

WFP and NGO Partners

- ❖ Partnerships with civil society organizations are crucial for WFP's work and the achievement of the organization's strategic objectives.
- ❖ Partnerships between WFP and Cooperating Partners are operationally managed at the WFP County Office level.
- ❖ WFP Headquarter's NGO Partnerships Unit provides guidance and support to Country Offices and cooperating partners; manages strategic partnerships with NGOs at the global level; collates and disseminate data and organizes the Annual WFP Partnership Consultations, an opportunity for WFP and partners to come together and engage in strategic dialogue.



What is a Field Level Agreement (FLA)?







The **Field Level Agreement** is the contract that all cooperating partners have to sign in order to engage in project implementation with WFP. The FLA ensures that the interests of both WFP and CSOs are safeguarded, and promotes global consistency in the partnership cycle.


The FLA budget template consists of one standard Excel document with separate worksheets. The template <u>cannot not</u> be modified.

When completing the template, the following colour coding applies:

- Yellow cells can be filled in by the user
- Green/Grey cells cannot be modified by the user as automatically generated through formula, or protected





Payments

There are different ways to calculate payments to cooperating partners under the FLA:

Summary of Calculation Methods:

Modalities	Calculation Method
I. Food Transfer modality	Rate per metric ton: MT distributed X rate per MT
II. CBT Transfer modality	Actual cost of services as per invoice or statement submitted
III. CS Transfer modality	Actual cost of services as per invoice or statement submitted
IV. Technical/Specialist Services	Actual cost of services as per invoice or statement submitted
V. CP Direct Support Costs	Actual cost of services as per invoice or statement submitted
VI. Management fee	7% payable amount for total CP's Direct Costs
